We are under way to start our 2024 Festival season. If you are interested in managing a concession booth this year, please complete the enclosed application form and return it to us as soon as possible.

Each space is 15' x 15'. If your concession booth requires a larger area, you will need to specify the number of spaces needed and pay for each space. The sale of non-alcoholic beverages is allowed if sold within your concessions booth, which includes the sale of food. Paid reserved parking is available near the Arts and Crafts area and free parking with shuttle service is located further out. If you need motel or RV reservations, you are encouraged to make them early as they sell out by the spring each year. The usage of generators is strictly prohibited in the concessions area.

The concession area is limited to the first 30 entries received. You will be notified of your space number early October 2024. Concession spaces are given priority based on the date that your application is received and on electrical needs. The Festival usually sells out of spaces, so register early! In the event that the concession area is filled, we will return your application and check.

WE TRY TO SEPARATE EACH VENDOR FROM A DUPLICATE. IT IS VERY IMPORTANT THAT YOU TELL US EVERYTHING THAT YOU ARE SELLING.

YOUR BOOTH MUST BE SET UP SATURDAY, OCTOBER 26, 2024 BY 9:00 A.M.

YOU CAN NOT BREAK DOWN YOUR BOOTH UNTIL SATURDAY, OCTOBER 26, 2024 AT 4:00 P.M.

After October 15, 2024 there is a \$25.00 Late fee

The Division of Hotels and Restaurants is required by law to license public food services, whether permanent or temporary. A representative will be at the park on Festival Day to inspect all food concession (profit and non-profit). If your concession does not pass this inspection, you will not be allowed to sell at the Festival and the Festival **will not** issue refunds. This applies to profit and non-profit.
