The City of Perry and the Florida Forest Festival and Parade Committee do not provide liability insurance for the protection of individuals, groups, organizations, businesses, spectators, or others who may participate in the annual Florida Forest Festival.

In consideration for participation in said Forest Festival, the individuals, groups, organizations, businesses, spectators, or others do hereby release and forever discharge the City of Perry, the Florida Forest Festival and Parade Committee or its offices, board, and employees, jointly and severally from any and all actions, causes of actions, claims and demand for, upon, or by reason of damage, loss or injury, which hereafter may be sustained by participation in the Florida Forest Festival and Parade.

This release extends and applies to, and also covers and includes, all unknown, unforeseen, un-anticipated and unsuspected injuries, damages, loss and liability, and the consequences thereof, as well as those now disclosed and known exist. The provisions of any state, federal, local or territorial law or statute providing in substance that releases shall not extend to claims, demands, injuries or damages which are known or unsuspected to exist at the time, to the person executing such release, are hereby expressly waived.
