If you are interested in managing a Special Concessions booth this year, please complete the enclosed application form and return it to us as soon as possible. **A late fee of \$25.00 will be assessed for entries received after October 15, 2025 (No Waivers and No exceptions)**

Special Concessions is defined as booths that **do not sell food/beverage items and do not sell Arts and Crafts items. In addition, flea market items are not allowed as well as drug-related products, fireworks, stink bombs, and the like.** If you have any questions as to whether an item would be acceptable to the Concession Committee, please feel free to give us a call.

**Special Concessions is also an area for non-profit programs to showcase themselves.** We encourage educational programs, environmental programs, and the like to consider a booth. This is your opportunity to be seen by 20,000 in one day!

**Each space is 10' x 10'.** If your concession booth requires a larger area, you will need to specify the number of spaces needed and pay for each space. Limited electrical outlets are available and space placement is made on electrical needs. You will be notified by early October of your space assignment. In the event the area is filled, we will simply return your application and your check. If you need motel RV accommodations, you are encouraged to make them soon; the rooms are sold out by the spring.
